Re: **Partial Withdrawal** to previously-filed "**AMENDED Objection to Prevailing Wage Determination (Holiday Pay)**":
International Union of Elevator Constructors, Local 12

Ladies and Gentlemen:

As previously advised, this firm represents International Union of Elevator Constructors, Local 12.

By letter dated March 31, 2011, we amended our initial Objection dated March 28, 2011 so as to include six (6) Missouri counties (Boone, Miller, Moniteau, Morgan, Stone and Vernon), in addition to the 54 Missouri counties listed in our initial Objection relating to holiday pay.

Please be advised that inclusion in our objection of *Boone, Miller, Moniteau and Morgan counties* was in error and we **therefore withdraw our amended objection as to these four (4) counties only.**

Our objection still stands as to *Stone and Vernon* counties, in addition to the 54 counties listed in our initial Objection. Accordingly, the 56 counties covered by our Objection, and in which the prevailing rate as to holiday pay is **\$1.47 per hour**, are:
